v. Executive Summary

Pallister Park Primary School is located within the Pallister Park area of Middlesbrough.

Many aspects of the existing facility meet the design recommendations within PartM of the Building Regulations, British Standard BS8300: 2009 which clearly outline access for disabled users.

In general the site has a good level of accessibility; this report has been conducted as a review access audit to determine the accessibility of the school. Recommendations have been made throughout the report to ensure the school is fully accessible and that managed procedures accommodate any areas/issues that are not accessible.
